Subject: **Petition for eradication of technological crimes and harassment crimes**

Dear Mr. President,

Our NPO, Technological Crime Victims Network, was founded on January 25, 1998, as a voluntary group under the name "Association of Victims of Radio Wave Abuse." Since then we have consistently focused on solving problems related to technological crimes which using media invisible to the eye, such as electromagnetic/ultrasonic waves to launch pinpoint attacks on the body and nervous system of certain individuals and harassment crimes committed by a specified small number/unspecified large number of individuals. So far we have identified more than 500 such victims spread all over Japan. Based on the responses to our detailed questionnaire survey, we were able to establish with some certainty in 300 of these cases that they are actually victims of technological crimes and harassment crimes. Our NPO deals with victims within Japan, but we are aware that victims to such crimes are coming forward all over the world, including in the United States. Incidentally, an association in the US refers to what we call technological crimes and harassment crimes as "covert harassment" and "overt harassment," respectively. Given that harassment refers to actions intended to persistently worry and annoy someone, covert and overt harassment refer to persistently worrying and annoying someone by covert and

overt means.

In each country, victims exposed to this kind of attack are making efforts to resolve the issue, but as yet have remained without a clue as to how to proceed. Convinced that you, Mr. President, are the only one with a key to this problem, we are submitting this petition to you. Allow me to list up below the facts constituting the crimes in question as derived from our questionnaire survey, followed by an itemized petition. Your kind and prompt attention to this matter would be most appreciated.

Facts constituting technological crimes and harassment crimes

- (1) Technological crimes are committed using technologies capable of tracking certain individuals by invisible means around the clock over a long distance.
- (2) Technological crimes are committed using spook technologies capable of influencing the physiological and motor functions, five senses, emotions, the desire for food, sex, and sleep, and thoughts of an individual by invisible means over a long distance.
- (3) Technological crimes are committed using technologies capable of making an individual hear voices and sounds by invisible means over a long distance.
- (4) Technological crimes are committed using technologies capable of making individuals see images by invisible means over a long distance.
- (5) Technological crimes are committed using technologies capable of launching pinpoint attacks on each part of an individual's body by invisible means over a long distance.
- (6) Technological crimes are committed using technologies capable of targeting individuals with substances.
- (7) The personal attacks made possible by technological crimes cover a wide range. It is believed that a system and network has been established that allows arranging these attacks in any way according to program, and that 24 hours a day, 365 days a year, anywhere in Japan.
- (8) Technological crimes are accompanied by harassment crimes.
- (9) Harassment is a crime that requires detailed arrangements, and therefore cannot be committed unless there is an organization in the victim's surroundings that plans and implements it.
- (10) Harassment continues regardless of one's location. It is therefore believed that the above organization is present everywhere (on a municipality basis) and is

connected via a communication network.

(11) Harassment requires constant surveillance. It is therefore believed that cutting-edge surveillance technology (wiretapping, spy cameras) is being used.

(12) The method adopted aims at doubling the damage by a combined mechanism of harassment and technological crime. It is therefore believed that both crimes are planned and executed either by one and the same organization or by several closely connected ones.

(13) Anyone can become a victim of technological crimes and harassment crimes, irrespective of age or sex. Many have been victimized from childhood.

(14) It is believed that technological crimes and harassment crimes have been around for about forty years.

(15) Suddenly becoming the target of both technological crimes and harassment crimes can trigger a panic attack in any individual. Panicking in this case would be the natural reaction of any human being. The idea being promoted is that such victims need to be committed to mental institutions. This is not the correct way to handle this problem. It is thought that committing victims to a mental institution is also part of the said criminal activities at work.

(16) Not only have these two crimes caused many victims to lose their jobs, but six victims have even lost their lives (of these, 3 committed suicide, one was killed, one died of heart failure, and one due to unknown causes). What we are dealing with here is clearly a destruction of the individual.

(17) Nearly all victims suffer from a lack of understanding on the part of their families, eventually leading to a family breakup. In a very few cases, the entire family is victimized. What we are dealing with here is clearly a destruction of the family.

(18) Many victims believe that the perpetrators of the crimes are among their neighbors. This often leads to trouble with neighbors, and in a few cases may even become the source of a crime. If this were to occur all over the country, it could lead to the destruction of society and eventually, of the state.

The above are the criminal facts derived from our questionnaire survey, but with a history of forty years, it is believed that present societies exist as a result of thoroughly committing both technological crimes and harassments crimes. For this reason, this problem is extremely important to understand for real-world society. But because technological crime is committed by means invisible to the eye, it seems that societies have been built up without the general public having

any knowledge whatsoever of this problem. Therefore, things would be very different depending on whether we build up a society by leaving the two crimes untouched and plastering them over or whether we try to solve the problem by putting the originators of both crimes in the proper perspective. For the latter, it is necessary to see through technological crimes. But to understand these crimes, you have to have experienced them. If you experience them, it seems you can experience only a small part, while they actually may be present on a grand level. At any rate, the results of the questionnaire survey carried out by our NPO present the clue to the facts of the matter. Having been a victim over the past forty years myself, I feel that I am well qualified to publish the results of this questionnaire survey. However, the more I know about this problem, the more I have come to think that solving it will require high level political decisions and a strong leadership capable of persuading the world to take measures based on a multinational agreement. And I think that the only one capable of providing this leadership is you, the President of the United States of America.

Petition Item 1:

Having explained to you that “tracking technology” putting at risk human rights, freedom, equality and democracy, and leading to absolute control of the population is in action, we petition you to take urgent measures, such as concluding a treaty aimed at stopping satellite surveillance of ordinary citizens, in order to protect not only the victims from this danger, but the citizens of the United States and people all over the world.

As mentioned under Criminal Fact (1), technology capable of tracking victims around the clock is in action, probably for the past forty years. Points that should not be overlooked in the context of these crimes are that the targets are ordinary citizens, irrespective of age or sex, some since childhood, who have not committed any particular crimes. Also important is that most of the victims testify that they do not know why they are the targets of these crimes. We hope you will try to understand this situation where innocent people, some from childhood, have been targeted by tracking technology over the past forty years. I would also like to call to your attention that this technology can be applied to all citizens, carrying the risk of absolute population control.

Subjecting people to around-the-clock spook activities alone is a serious violation

of human rights and infringes on an individual's freedom. Obviously it also infringes on equality as it separates people into those who know this technology and those who don't. We hope you are fully aware that, if this technology were used by the state against its people, the state would have absolute power and eventually renege on democratic rule. In view of the fact that this technology is made possible by the use of satellite facilities, we ask you to take urgent measures, such as concluding a treaty aimed at stopping satellite surveillance of ordinary citizens, in order to protect not only the victims from the dangers of spook technology, but the citizens of the United States and people all over the world.

Petition Item 2:

We petition you to accept the fact that systemized and networked torture technologies in conflict with the “Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment” have spread to every nook and corner of society and to eliminate these promptly in order to prevent that they are put to abusive use.

As mentioned in Crime Facts (2) to (6), individuals are being spooked and at the same time subjected to a variety of pinpoint attacks using technological means. And as stated in Crime Fact (7), these attacks continue 24 hours a day, 365 days a year. Wherever these individuals are, it is as if they are kept in a constant state of torture. These are criminal acts which contravene the “Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment.” We hope you will try to understand this situation where innocent people, some from childhood, are being subjected to torture for unknown reasons, and that the technologies which make these crimes possible have been systemized and networked and spread to every nook and corner of society. We ask you to eliminate these promptly in order to prevent that they are put to abusive use.

Petition Item 3:

We petition you to accept the fact that human control does exist and to promptly stop its abuse.

As mentioned in Crime Fact (2), technological crimes are committed using technologies capable of influencing the physiological and motor functions, five

senses, emotions, the desire for food, sex, and sleep, and the thoughts of an individual by invisible means over a long distance. Rather than merely influence, the word control would be more appropriate to describe the level of these actions. But as long as one is not aware of this abuse of technology, it is impossible to recognize. I can attest to the imperceptibility of this technology as I myself have been aware for the past forty years that I am a victim, although I had been completely in the dark during the quarter of a century before May 17, 1995, when the concentrated attacks started, and had simply been dealing with my predicament as a personal problem. Influencing the physiological and motor functions, five senses, emotions, the desire for food, sex, and sleep, and the thoughts of an individual is a dreadful matter and proves that we have entered the age of human control. We hope you will understand that this technology is already being abused and take prompt measures to stop this abuse.

Petition Item 4:

Because dependence on human control technology produces human wrecks with more severe dependencies than those relying on drugs, and places society under a spell from which there is no escape, we petition you to disclose the pertinent information promptly to alert the public to the danger.

Having been victimized by human control technology myself, I will describe here the effects this technology has had on me. I was subjected to mind control through image transmissions and stimulating impulses which induced me to act in certain ways. Even though something was urging me on, I was fully conscious and I felt that I acted of my own volition. But at that time I was still unaware that a technology was at work. Urged on by image transmissions and impulses from this stimulating technology, I was made to take a car trip, but as I was driving through the Tohoku district, the image transmissions completely broke off. At the same time, I experienced such extreme panic that I was never able to drive a car again. What I understood from this experience is that, if nothing is done about human control technology, society will certainly find many ways of using it, but if it stops for some reason, society will be left with totally disabled human wrecks. If you live your life from childhood days thinking that this is normal, stopping of the attacks will leave you an absolute wreck. You can see the future from this experience. The result of a development achieved by mobilizing vast amounts of

money and top brain is a herd of human wrecks. I believe that this technology works in the same way as a narcotic: the more you get, the less you can break away from it. Once people realize this, information about the existence of human control must be disclosed without delay, and attention must be called to the dangers involved. Then the immense budget and the top brains could be applied to the kind of development you can entrust the future to. We hope you are fully aware that the helmsmanship in this matter is entrusted to you, Mr. President.

Petition Item 5:

We petition you to help correct the practice that individuals showing the effects produced by the technology are classified as suffering from schizophrenia in psychiatric medicine.

As pointed out in Crime Facts (3) and (4), the transmission of voices, sounds and images is typical of these technological attacks. But psychiatric medicine diagnoses voice and sound attacks as auditory hallucinations and image attacks as visual hallucinations, and treats the individual as a sick person suffering from schizophrenia. Suddenly becoming the target of both technological crimes and harassment crimes can trigger a panic attack in any individual. Although panicking in this case would be the natural reaction of any human being, in some instances people are committed to mental institutions just by looking at them. Schizophrenia is recognized in psychiatric medicine as a mental disorder worldwide, but seeing a disorder that is caused by technological means being classified as a disease is unacceptable for the victims. To overturn the opinion of the medical authorities, the technology must first of all be revealed to the public. In order not to leave an adverse legacy to posterity, as people tend to attach authority to the medical profession, we ask you to promptly disclose information on human control technology and help to correct the attitudes of psychiatric medicine.

Petition Item 6:

We petition you to disclose information on technologies within the sphere of secret military technology which can be used to commit technological crimes.

It is a serious problem that the general public does not know that state-of-the-art

technology has reached the stage where it can be used to control people. Keeping a lid on military technology because divulging this information would be counterproductive for reasons of national security is not difficult to understand. But is it worth to keep a technology secret that exposes innocent children to technological abuse? The more secret it is kept, the more people will be annihilated. We ask you to actively disclose information on technologies within the sphere of secret military technology which can be used to commit technological crimes.

Petition Item 7:

Because rising tensions in these times of the "war on terror" give justification to absolute population control, we petition you to pursue policies to actively reduce these tensions.

Anti-terrorism measures are likely to be a major reason for not disclosing technological crimes. Since the 9/11 synchronized terrorist attacks in the US, there is consensus in the world on the need for counterterrorist measures, but if these counterterrorist measures are thoroughly enforced, they could lead to total population control and lend justification to the use of the spook technologies mentioned earlier. From the victims' point of view it looks as if entire populations have already been subjected to tracking technologies for a long time, so these counterterrorist measures were probably concocted to immobilize the spook actions. Setting aside the question of true or false, it is clear that the stronger counterterrorism measures, the more strangled will be the population. To solve the issue discussed here, the tensions created by counterterrorism measures following 9/11 need to be reduced. This requires the power to make high-level political decisions and strong leadership to persuade the world. The first half of the 20th century was spent in wars, the second half was taken up by the cold war era, when many countries in Asia and Africa, acting as proxies for the US and the Soviet Union, experienced great hardships. If we turn the 21st century into the age of the war on terror, the people of the world, including those in the developed countries, will be plunged into a state of absolute technological control. No one could wish for this to happen. We urge you, Mr. President, to pursue a policy that would bring about fundamental changes in the war on terror started by the previous Bush administration. This would also lead to a solution of the issue raised here.

Petition Item 8:

We petition you to exercise world leadership with a strong commitment to civilian control.

I think the technologies used in technological crimes were originally developed for military applications. These military technologies will be put to use in civilian programs over the next 30 years, I believe. The fact that these are cutting-edge military technologies, that they involve top brains, and that technologies no longer needed by the military are allowed to be put to general use on the civilian population is indeed a great misfortune for humanity. To win at any cost is the mission of those to whom the military is entrusted, but it is the task of the politicians to resist the will of the military. Since the 9/11 terror attacks, the previous president, Mr. Bush, had been pursuing policies that gave the impression that he intended to make the 21st century another century of war. But in this emergency situation, he seemed to take a lot of holidays and enjoy himself, judging from media reports showing him horseback riding on his Texas ranch. This makes one think that subjects such as civilian control probably were far from his mind. Politicians must draw a line between themselves and the military profession drilled to win at all cost. I think this is fundamental to civilian control. For a time, books such as "The rise and fall of empires" and "The clash of civilizations" were very popular, but it seems that the people of Japan and around the world do not wish any empire to rise or any civilizations to clash. Learning from history does not mean that you prepare yourself for something to happen, just because the same thing happened in the past, but to make an utmost effort that the same thing does not happen again. All that military bureaucrats can do to learn from history is to prepare for any possible risks, while politicians have many means to avert danger, including diplomacy and domestic politics. Statements and actions reflecting civilian control in this wider sense is what is demanded of you, Mr. President. To be able to do this, you need many capable advisors. Former President Kennedy awakened the people to their possibilities by exhorting them in his inauguration speech, "Ask not what your country can do for you – ask what you can do for your country," the question is what kind of statements and actions will be forthcoming from you, Mr. President. You should focus entirely on statements and actions that reflect civilian control in the wider sense. This would imbue not only the American people but the people of the

world with the same emotions and strength as Kennedy did. You should respond to the rationale underlying the choice of the American people. This is the time for big political decisions.

Petition Item 9:

We ask you to devote yourself to solving the current political and economic turmoil arising from a hysterical kill-or-be-killed state of mind.

The state of mind that produces harassment attacks (persistently worrying and annoying someone) is extremely dangerous as it involves a good degree of hysteria and an absolute unwillingness to consider other points of view. When this state of mind and the win-at-all-cost attitude of the military bureaucracy combine to rule, there is a danger that the lives of people and nations will be placed at risk. The problem is that to understand the current political and economic situation, one must be aware of this state of mind. Anyone who represents an obstacle to the win-at-all-cost attitude must be rooted out. Using means such as globalization, liberalization and deregulation, and the computer needed by the military as a tool, thorough efficiency is pursued. This has taken us to where selfishness as never experienced before triumphs unchallenged and where there is no way to survive unless we become fighters for selfishness ourselves. Behind this tendency, I have to wonder that there is a deranged kill-or-be-killed state of mind. We would like you, Mr. President, to root out this state of mind to the core. Taking a clear stand against the hysterical attitude of persistently worrying and annoying to win at all cost is also needed in terms of economics. This could be called civilian control in the economic sphere. I think that freeing the world from this state of mind and never letting it gain ground again will lead to economic revival. This, I am convinced, will save the people of the world as well as your nation.

Petition Item 10:

We petition you to assemble a team of top brains tasked with bringing to an end this information age that will inevitably lead to mind control of the population by facilitating a return to the origins of the Buddha who totally denied the information age, and look ahead to the future without being taken in by past scientific research.

Speaking of psychology, Sartre, who is credited with having established psychology as an academic field, wondered whether it had not been the Jews who spawned psychology. Heedless of Sartre's concerns, research in this field later went ahead at top speed, and adding to that brain research, implant technology, wireless transceiver technology, digitalization and computer technology, we have now reached a stage where human psychology can be fully manipulated. We have entered an era where technology is used to sway human mental processes and insecurity reigns supreme. This insecurity could well be the flip side of the information age. But in this age, we need to return to the origins of the one who was able to look beyond this insecurity. We Japanese live our lives without consciously practicing any religion, although most families are supporters of a Buddhist temple. Temples are dedicated to Buddhism founded by Buddha, and I can't help but think that the figure of the sitting Buddha totally rejects this information age. The truth that Buddha demanded is in this very figure, and anything else should be regarded as useless information. Those who live by this information are the worldly people, and today's information society is an extreme manifestation of this. Why do I talk like this? Because I think that people cannot go on living if today's information-oriented society prevails. If the extremely hysterical attitude of wanting to control the minds of all people comes to dominate, we will clearly be caught in the grips of invisible technology from which we will not be able to extricate ourselves, no matter how we try. And if this is an inevitable consequence of the information age, then this age must be brought to an end. Mr. President, we ask you to free yourself from the dogma of past academic research and assemble a team of top brains to deliberate on what should follow after the information age. We must stop this military-led society because depending on military technology can make people so miserable, even if it is 30 years ahead in time.

Petition Item 11:

We petition you to eradicate the source of harassment crimes that follow a clear pattern of causing panic attacks by outrageous harassment, promoting the idea that such victims need to be committed to mental institutions, and driving those who refuse to accept this to suicide or crime, and to stop these crimes from spreading or becoming part of everyday life.

Attacks by psychological warfare have also been incorporated in harassment

tactics. Common characteristics of the tactics used as derived from the survey up to now are: (1) surveillance by a multitude of people, (2) stalking, (3) repeated/continuous attacks, (4) well-timed attacks, (5) surveillance, (6) systematic attacks, (7) organized attacks, (8) manual-based attacks, (9) country-wide networking, (10) history extending over 40 years, and (11) absurd behavior. We also came to know that the last item, absurd behavior, describes the tactics as a whole.

The attacks are so absurd, that they defy any standard of common sense or normalcy. If they were within the realm of common sense, the police, lawyers, public officials and politicians would agree to act, but because they are absurd, people tend to adopt an attitude where they try to thoroughly distance themselves from the core of the problem. As people under attack by this all-out absurd harassment find no one who is willing to help them, they become isolated and increasingly under pressure, and finally are plunged into a state of panic, the treatment of which is entrusted to mental institutions. Victims who refuse to accept this choose either suicide or, compelled by forces beyond their control, commit crimes. This pattern is clearly backed up by the survey results. It must be possible to find out the real identity of those behind crimes with such a uniform intention. We ask you to stop harassment crimes as soon as possible to prevent them from spreading and becoming a part of everyday life.

Petition Item 12:

We petition you to reflect on the information age in the realization that religion and science are incompatible in Buddhism.

The figure of Buddha assumes great importance as the origin for reflecting on the information age. Another important point is that Buddha was no figment of the imagination but a real person who died a natural death. One's train of thought should start from the realization that the lotus position was to Buddha the ultimate truth. People in the West continue to meditate in search of truth, but Buddha, whose sitting figure is truth itself, did not meditate. Rather than pursuing ideals by meditation, the figure sitting cross-legged to become one with all things is the embodiment of truth and an example of how we should live our lives. Buddha's disciples trained to overcome the human urge for self-flagellation to come ever closer to Buddha. The figure of Buddha who does not try to meditate in order to

seek truth totally negates science. This is another point which we hope you, Mr. President, and others in the West will try to understand. In Buddhism, therefore, religion and science never merge.

(“Self-flagellation,” in Buddhism, is the whip that admonishes the disciples to deny the human urge to reflect or meditate on many things in order to approach the ultimate state of the Buddha. In technological and harassment crimes, on the other hand, flagellation refers to a whip that constantly drives people all the way to their death. Please note this difference.)

Regarding the thought processes of the brain, I would like to add something from my experience as a victim of brain attacks. As mentioned in Crime Fact (2), technological attacks influence the thought process among others in a way that others can access the thought processes taking place in the brain. The attacks were initiated while I was sleeping and my brain was at rest. After inputting some kind of information into my brain, it was set in motion and the required information was extracted. It is just like someone putting a coin into a slot machine, pulling down the lever to operate the machine, and a result coming up. Another way of looking at it is aiming TEMPEST at an individual’s head. I have experienced this several times. It made me understand that the human brain is activated automatically by incoming information to start a decision-making process. This may be the natural workings of the brain, and is another proof of the greatness of Buddha who was able to subdue this nature.

Petition Item 13:

We petition you to make the 21st century a dream-inspiring century by freeing people from the “invisible hand” guiding the economy and the “invisible hand” guiding technological crime and harassment crime.

There seems to be a dispute going on both in the East and the West as to whether human nature is fundamentally good or basically evil. According to the teachings of Buddha, humans are naturally evil because it is in their nature that they have to use their brains. Looking at the way the U.S. economy works with its high commitment to liberalization and deregulation, one gets the impression that the view prevails that humans are inherently good. The guiding principle of the American people seems to be not only the wish to do away with many existing

regulations, but also a dislike of authority and a desire to demolish it. In the end, this guiding principle may create an age of complete social uncertainty by ultimately influencing the human mind using invisible technology. After having removed many existing regulations, will they introduce Adam Smith's idea of the "invisible hand" and persuade people that everything will settle down naturally if they are led by the invisible hand? Whose hand is the "invisible hand"? This kind of economic activity caused an unprecedented economic crisis, forcing the U.S. government to announce fiscal stimulus measures equal to the size of Japan's national budget. The U.S. is also trying to force other countries to take similar action. Anything that causes an economic crisis guided by the "invisible hand" and appropriates the people's taxes should be viewed as a tax absorption system. Because the forces which caused the economic crisis and reared this "invisible hand" are inherent in the makeup of the U.S., straightening this out would be your foremost task. But the people are in the firm grip of a different "invisible hand," referred to here as technological crime, and are entangled in a network of harassment. As mentioned earlier, in this situation you should under no circumstances use the words of former President Kennedy, "Ask not what your country can do for you – ask what you can do for your country." What counts now is what you, Mr. President, can do for the people. One thing you should do is to rid the people of the "invisible hand" guiding the economy and the "invisible hand" guiding technological crime and harassment.

Another is to look back on the history of the U.S. Who was it that derived the most benefit from the fact that your country was a frontier country? As everybody knows, it was the Jews. That is why you should first of all ask for their cooperation. This is an emergency and justifies any means. The least you can do is to have them donate the entire amount invested in your current fiscal stimulus measures. And please overcome this economic crisis at a stretch.

I would also like to ask you to take another look at the blessed soil of the United States. While your country possesses rich land resources unrivaled in the world, it is inhabited by only roughly 300 million people. The U.S. should have a population equal to that of China or India. Please think about the kind of economy that would be required in that event. On this basis you can start to think of a way of life for the common run of the people. Please start out from a totally blank page in building up an ideal living system for humans whose only living space is the

earth. The people of the U.S. left conservative societies behind to build up a new country, and this time I would like you to advocate a frontier along these lines. The proponent of this idea should be awarded a newly established America Prize that is more prestigious than the Nobel Prize. We ask you to lead the United States to the era of the new frontier.

And in line with the above, there is one more major task you can perform. If the U.S. would decide to take in 1000 million people, there would be a possibility to take in the Israeli people. And this would open the way to solving the Middle East problem. No country could do this except the U.S. The project should be handled by the Jews themselves, using their own money accumulated over generations. Everything should be financed by money the Jews put up themselves. We petition you to lead the way to a 21st century where all the people of the world share their dreams and happiness.

Petition Item 14:

We petition you to determine what course of action to take after having put an end to the invasion of people's consciousness by technological means, rather than proceeding from a situation that is the result of technological invasion of the human mind.

It is important to realize that today's society is the result of long-term technological invasion of the human mind. For more than 40 years, technological crimes capable of invading people's consciousness have been committed. We should not forget the reality that uncountable people had their minds altered in this way. I think that individuals are being manipulated by invading their consciousness, making them think, feel and act as if it was them doing all of this. This could also be used to arouse romantic feelings for someone who may be of the same sex, resulting in sexual perversion.
